WHEREAS, the RFQ was sent to suppliers, namely: 1) Ansons, Makati; 2) Rustan Supercenters, Inc.; 3) Automatic Appliances, Inc.; 4) Abenson Ventures, Inc.; 5) Villman Computers; 6) Robinsons Appliances; 7) Asianic Distributors, Inc.; and 8) Western Appliances;

WHEREAS, three (3) suppliers, namely: 1) Rustan Supercenters, Inc.; 2) Automatic Appliances, Inc.; and 3) Abenson Ventures, Inc. submitted proposals on or before the December 4, 2019 deadline;

WHEREAS, the Human Resources Department determined the proposals of Abenson Ventures, Inc. for Lot 1 and Automatic Appliances, Inc. for Lot 2 as compliant with PhilGuarantee's Terms of Reference and most advantageous to PhilGuarantee. A copy of Memorandum dated December 5, 2019 is herein attached as Annex "A" recommending the award of Lot 1 to Abenson Ventures, Inc. and Lot 2 to Automatic Appliances, Inc.;
