RESOLUTION NO. 2020-023

WHEREAS, the Facilities and General Services Department (FGSD) requested the Bids and Awards Committee (BAC) for the procurement of a service provider for the security service requirement of PHILGUARANTEE with an Approved Budget for the Contract of Pesos: Eight Million Two Hundred Sixty Four Thousand Five Hundred Ninety One (P8,264,591.00), inclusive of all applicable taxes;

WHEREAS, pursuant to the approved Updated APP for FY 2020, the mode of procurement for Security Services for PHILGUARANTEE offices is Competitive Bidding with an estimated budget of P8,264,591.59;

WHEREAS, the Invitation to Bid was posted at PHILGUARANTEE and PhilGEPS websites and at PHILGUARANTEE-Jade office Bulletin Board, for seven (7) calendar days;

WHEREAS, in response to the aforesaid invitation, representatives from ARM Corporate Security Services, Inc. (ARM), Lifeguard Archangels Security Agency Corp. (LIFEGUARD) and JSL Security Agency Inc. attended the pre-bid conference on 20 August 2020;

WHEREAS, ARM, LIFEGUARD and ICT Security and Investigation Agency, Inc. (ICT) submitted bid documents before the deadline on 01 September 2020; 1:45 P.M.;

WHEREAS, during the opening of bids on 01 September 2020; 2:00 P.M., ARM, LIFEGUARD and ICT were determined to contain all the bid requirements for both Technical Components (Eligibility and Technical Requirements) and Financial Components, hence, were rated "**PASSED**";

WHEREAS, Financial Bids were read as follows:

WHEREAS, pursuant to BAC Resolution 2020-011A the BAC, based on the bid evaluation and recommendation made by the TWG declared the bid of Lifeguard Archangels Security Agency Corp. as the Lowest Calculated Bid;

WHEREAS, on 18 September 2020, in view of the COVID-19 pandemic being an exceptional circumstance and since government agencies should respond to inquiries within 15 calendar days from receipt thereof, the BAC agreed to give the TWG an extension of fifteen (15) calendar days within which to complete the post-qualification;

WHEREAS, on 05 October 2020, the TWG upon verification, validation and ascertainment of the statements made and documents submitted by LIFEGUARD determined that the documents submitted by LIFEGUARD passed all the criteria of the post-qualification (legal, technical and financial), thus, was recommended to be declared as the Lowest Calculated and Responsive Bid and the award of contract;

NOW, THEREFORE, in consideration of the recommendation of the Technical Working Group, the Bids and Awards Committee (BAC), hereby **RESOLVE** as it is hereby **RESOLVED**:

- a) To declare the bid submission of **Lifeguard Archangels Security Agency Corp.** as the **Lowest Calculated and Responsive Bid** for the procurement of a service provider for the security service requirement of PHILGUARANTEE; and
- b) To recommend the approval by the Head of the Procuring Entity (HoPE) of the award of contract for the procurement of a service provider for the security service requirement of PHILGUARANTEE to **Lifeguard Archangels Security Agency Corp.** in the amount of **Pesos: Seven Million Two Hundred Eighty Two Thousand Four Hundred Twenty Two (P7,282,422.00)**, inclusive of all applicable taxes.
